4. I attach the following documents:
 - a) Diploma of high-school graduation in the language of origin as a notarized copy and another one translated in Romanian, as a notarized copy (the original diploma, not a copy, is to be registered before the interview).
 - b) Notarized copy of the birth certificate
 - c) Photocopy of the passport with the Romanian visa for study
 - d) 2 recent photographs
5. I agree to respect the laws of the Romanian State, the University rules (including those regarding social life) and University *Charta*.
6. I was informed that the tuition fees and, by case, the accommodation costs have to be paid with anticipation once every 3 months, these can be changed after a preliminary notice.
7. I was informed about having the following rights during the period for which I have paid taxes:
 - a) to participate at the learning process established by the university (lectures, seminars, practical courses, summer practice, hospital practice, etc.) under the same conditions as Romanian students.
 - b) to attend the Romanian courses and learn spoken and written Romanian so that in the third year I shall be able to communicate in Romanian with patients who have no knowledge of English. The passing of the Romanian exam given at the end of the second year is obligatory in order to enroll in the third year.
 - c) free access to the university libraries.
 - d) a cheap accommodation in the university hostels at a special price for students, if there are available rooms, during the period of time for which I pay the tuition fees.
 - e) to receive, if I request it, a certificate for different authorities (customs, traffic department, embassy, etc.) and scholarly results for the study years graduated, as well as the analytic programme.
 - f) to receive from the University the necessary documents for getting a visa for staying in Romania during the regular study period for which I have paid the tuition fees.
 - g) free medical care, during the time period for which I have paid the tuition fees as a student at the University of Medicine.
8. I was informed that if I fill in the form with incorrect or false data , or if I give inadequate documents (which the Ministry of Education and Research of Romania finds to be false or inadequate), this registration will be cancelled, and I shall have to suffer the legal consequences.
9. I was informed that, if the final registration cannot be completed or is cancelled due to one of the reasons mentioned under paragraphs 3, 6 and 8, the University will not return the exam fees, the tuition fees, or the accommodation costs if I had stayed in university hostels and attended lectures and practical courses up to the moment of rejection.
10. I was informed that I have to pass the Admission Colloquium, consisting in the English test and interview in order to enroll in year one in the university year 2005/2006 as part of the module in English.
